**The American Shropshire Registry Association is gearing up for the first-ever Stars of Louisville Shropshire Sale. You have been invited to enter one or more elite females. Being a first time sale, effort has been made to ensure that high quality animals are entered.** The sale committee consists of Chairman Randy Rife, Manager Becky Peterson, Bob Johnson, Gary Brockmann, Jim Brandt and Mark McCabe.

- You may enter Bred Yearling Ewes and Bred or Open Ewe Lambs
- Ultrasound Pregnancy Scanning available from Nancy Miniter at \$5 per head
- Ewe Lambs will be eligible to compete in the 2010 Yearling Ewe Futurity, if nominated
- *Consignor may retain Show Rights through 2009 NAILE National Shropshire Show (Monday November 16) as approved by NAILE*
- Consignors are encouraged to promote their entries and nurture their prospective buyers.
- There will be a minimum bid of \$300 on ewe lambs and \$400 on yearling ewes.
- Entries Close September 21

We will be promoting the sale heavily. The sale catalog will be available by October 1. It will be mailed with the October 2009 Shropshire *Voice* and will also be available on the ASRA website [www.shropshires.org](http://www.shropshires.org)

Consignors are invited to submit well-posed photographs of their entries which will be viewable on the website with the catalog. Photos should be submitted by October 15<sup>th</sup>.

## **ANIMAL IDENTIFICATION AND HEALTH REQUIREMENTS**

All sheep consigned to the Stars of Louisville Sale must be positively identified with an eartag or tattoo that corresponds with the certificate of registration issued by the ASRA. All sheep must also be identified by an eartag or tattoo approved by the USDA and accompanied by an approved interstate health certificate issued no more than 30 days prior to this sale. The Kentucky Department of Agriculture requires that sheep or lambs may not originate from known trace, source or infected Scrapie flocks as determined by the USDA APHIS and that sheep must be free of scabies and soremouth. All animals must be guaranteed to be free of the gene for achondrodysplasia ("Spider"). All animals must be QR or RR at Codon 171.

## **ENTRY FEES, ENTRY DEADLINE & COMMISSION**

YOU MUST BE A MEMBER OF THE ASRA TO ENTER SHEEP. A fee of \$50 per head will be required at the time of entry. Entry fees are non-refundable. Substitutions will be allowed.

The deadline for entries is Monday, September 21. Entries will be accepted after this date but may not appear in the Sale Catalog.

A commission of 10% will be charged on the full gross amount. All applicable commission is charged on any "NO SALES."

Settlement on sheep sold in the sale will be made within 4 weeks of sale date.
