2010 was the ninth year for our Shropshire Ewe Lambs and we had 109 nominated. The total amount for the futurity pool was \$2180. Twenty-two of the thirty-one ewe lambs competing for points showed in the NAILE National Junior Show. NAILE junior points are double and placing breaks ties. Only five point totals counted and only two ewe lambs per exhibitor are eligible for payment. Futurity payments will be mailed within thirty days.
